It has decided to facilitate and encourage faculty members working in its various institutions to go for Ph.D/Research Degrees, while in service. A committee was constituted by KCCS to frame the proposals for motivating faculty members of various Khalsa Institutions to acquire Ph.D/Research Degree after joining service on regular basis. The recommendations of the

1) Every regular faculty member of Khalsa Institution should be motivated to obtain Research

- 2) All the teachers who are below the age of 45 years/and have more than 15 years of service left will have to acquire Ph.D in their respective subjects/interdisciplinary subject falling which the management may freeze the financial benefits including the Dearness Allowance.
- 3) Those acquiring Ph.D degree will be paid three incentive increments after the award of Ph.D.
- The management will encourage such teachers to participate in international/national conferences and will also reimburse the air fare/railway fare/registration fee on the recommendations of the college Principal.

Proceedings of Principals' Meeting held on 16-05-2022 at 3:15 PM under the Chairmanship of Honorary Secretary Ji

The Meeting started with the recitation of 'Mool Mantar' & 'Shabad Tum Datte Thakur Pratipalak'

Honourary Secretary Rajinder Mohan Singh Chhina Ji welcomed all the Principals to the meeting. After discussions, the following decisions were taken on presented agenda:

1. To Ensure Discipline Amongst Students on College Campus

Honorary Secretary Sir directed all the Principals to ensure the proper discipline amongst the students on the Colleges' Campus. He said that there had been various lapses in the security and we need to overall the security system for which Principals must make concerted efforts. He issued the following directions:-

- a. The responsibility of the Security Officer will be fixed in case of any in-disciplinary/unlawful entry of any anti-social element within the campus.
- b. The Identity Cards be mandatorily issued to all the students of all the institutions at Khalsa College Campus to check outsiders.
- c. Every vehicle entering campus be checked. Only girl students who will fulfill criteria will be allowed cars/four-wheelers inside the campus after valid entry pass is secured from Principal.
- d. The proper parking of the vehicles would be ensured at designated areas. The haphazard parking on roadside not to be allowed. The parking fees from the students would be uniformly taken by all institutions on daily/monthly/yearly basis on rates to be discussed by Principals amongst themselves.
- e. The rates of the parking fee should be uniform in Khalsa College and other Colleges including Khalsa College of Veterinary & Animal Sciences, Amritsar and Khalsa College of Laws.
- f. The barriers should be properly placed to curtail the vehicles in the parking lots/areas. $^{\mbox{\tiny Y}}$
- g. The vehicles with tinted glasses, triple riding is strictly banned on the campus.

h. The gates will be opened and closed strictly as per the schedule to be decided by Principal, Khalsa College.

All the principals agreed and noted the same.

2. Expenditure by Principals on Minor Repair Works

Though the major works are undertaken by Works Department, the Principals are entitled to undertake minor repair of civil works/sanitary/electricity and others up to the specific financial limits;

- (1) Khalsa College of Nursing, (2) Khalsa College of Laws, (3) Khalsa College Chawinda Devi, (4) Khalsa College of Physical Education and (5) Khalsa College International Public School, Ranjit Avenue, Amritsar were given the rights to spend Rs. 10,000/- per month for these works
- (2) The rest of the Colleges/School have already been issued the rights for monthly expenditure and the Principals might use from these earmarked finances to carry on such works.

All the principals agreed and noted the same.

3. Vehicle Insurance through proper quotations,

All Principals have already been written that they must adopt proper procedure for Insurance of the vehicles. The quotations, at least one from national level company, be taken, rates, premium discounts, no claim bonus etcs be taken into accounts and compared while taking insurances for vehicles.

All the principals agreed and noted the same.

4. Timely Premium of Student Insurance Policy

All Principals were asked to mandatorily take premium of Students Insurance Policy at the time of fee payments by the students every year as there had been cases when premium was not taken. The case of Insurance will not be entertained by the Insurance Committee in case of non-payment of premiums.

All the principals agreed and noted the same.

5. Proper Parking of Vehicles

Honorary Secretary Sir directed all Principals that the parking lots/area should be ear-marked for the proper parking of the vehicles throughout the campuses. They must ensure the timely issuance of passes for vehicles and uniformity in parking fee as per the instructions already issued be ensured.

All the principals agreed and noted the same.

6. Best Research Award

It was decided that from the next Academic Session-2022-23, while the Best Teacher Award would continue as it is, there are changes of criteria for Best Research Award for Colleges. (a) From now onwards, the amount of 10% of the total grants received by the teacher/teachers from any Central/State Institution/Agency would be paid to him/her as the Award by the Management and grant will be fully utilized as such.

(b) It was also decided that Rs. 50,000/- would be paid to the student/staff member for getting the Patent registered in name of the College. If there are more than one person involved in registering the Patent or Research Award, the Award money would be equally divided amongst the Members.

All the principals agreed and noted the same.

7. Pre-Matric, Post Matric Scholarships,

The concerned Principals were asked to take the advantage of the Pre-Matric and Post-Matric Scholarship scheme of the governments as per rules and norms already discussed. They must also help the students in filing their cases with the Government for the receipt of the scholarship amount as the amounts is to be deposited in Students' accounts by the government as per rules.

All the principals agreed and noted the same.

8. Submitting of Salary Bills in Time,

As the directions have already been issued, all the Principals were asked to send their salary bills in time, so that the salary of the staff will be paid in time.

All the principals agreed and noted the same.

9. Installation of latest Bio Tap Machines

The Bio-tap Machines, in case of any fault/damage, will be replaced with the new machine, equipped with the latest technology and prior permission/sanction be taken from HSO.

All the principals agreed and noted the same.

10.FCRA Account of the Society

All Principals were asked to help the Society in getting donations from the Donors worldwide through FCRA (Foreign Contribution Regulation Amendment Act) Account, or local Account of the Society as the accounts are operational. The details of these accounts has been displayed on Society's Website https://khalsacollegecharitablesocietyamritsar.org

All the principals agreed and noted the same.

11. New Education Policy-2020

Honorary Secretary Sir directed Principals to make required efforts to implement the New Education Policy 2020 as per the guidelines of the Government and Affiliated Universities/Boards.

All the principals agreed and noted the same

12. Admission campaign through Social Media

Honorary Secretary Sir said that the role of social media is very strong and these tools be used by the Principals of Schools/Colleges admission campaigns. They must pay special interest in this regard and send report regarding;

- (a) Their Active official social handles (with username) of Facebook, Instagram, Twitter, LinkedIn etc to this office.
- (b) If any institution is not operating any social media platform, it must create its official social media accounts on the above mentioned platforms.
- (c) The Principals are also required to take steps to increase subscribers by Managing/promoting social media accounts of their respective institution.
- (d) They are also required to identify the Fake Social Media accounts of their respective institution and to take appropriate action against the admin of the said handle/s.

All the principals agreed and noted the same.

13. Admissions for the Session 2022-23,

All the Principals were asked to do concrete efforts to meet the target of admissions in the new session i.e 2022-23.

All the principals agreed and noted the same.

14. Payment of Vehicles' Insurance/Passing/Tax in time

The payment of Vehicle's insurance/passing/tax must be made in time as any lapse in this regard would be taken seriously and the concerned Principal would be responsible for any late payment/fine charges in this regard.

All the principals agreed and noted the same.

15. Proforma for Annual Increment of Teaching Staff,

The Proforma for annual increment of Teaching Staff in Schools/Colleges has been approved and all the Principals must send their teaching staff's annual increment cases as per this proforma after recommending the same to HSO.

All the principals agreed and noted the same.

16. Notice/Appreciation to the Teaching/Non-Teaching Staff in time,

As the instructions have already been issued, the notice/appreciation should be issued to the staff members in time so that the deserving staff gets incentives, while non-deserving one is de-incentivized for their negligence/dereliction of duties. The cases of extension in probation must be sent as per instructions already issued.

All the principals agreed and noted the same.

17. Security deposit/payment of electricity bills by Mess/Canteen Contractors

That during the signing of the agreements of contracts for Mess/Canteen/Shop etc., the clause regarding the security deposit and payment of electricity bills in time otherwise penalty to be imposed must be primarily mentioned. The copy of the each of the Agreement be send directly to the Manager Projects.

All the principals agreed and noted the same.

18. To Ensure Green & Clean Campuses

Honorary Secretary Sir directed all the Principals that they must keep their campuses green & clean and proper disposal of garbage be ensured. There should be no littering, and garbage bins separately for organic and non-organic waste be installed all over the places on campuses. The Principals were also asked to plant maximum trees in the upcoming rainy season.
